

# 「まなビューア」使用許諾書

「まなビューア」(以下「本ビューア」という)を使用する際には、次の「ソフトウェアのご使用条件」の全ての条項に同意する必要があります。本ビューアを利用された方は、下記、「ソフトウェアのご使用条件」の各条項に同意したものとみなされます。本「ソフトウェアのご使用条件」をご確認、ご理解頂いた上で本ビューアを使用してください。
